

Do You Collect Elongated Coins?

Elongated coins (so-called because of their shape after they are rolled) are part of what's known as "exonomia" — that is, they fall outside the usual numismatic interests. But rest assured, if you have a few, a few hundred, or a few thousand of them, you are not alone.

The first US elongateds were rolled in 1893 at the Columbian Exposition in Chicago, Illinois. Over the next few decades, entrepreneurs appeared with their dies and rolling machines at many fairs and expositions, eager to provide visitors with an inexpensive and unique souvenir. A man who operated a penny machine at the 1933-34 Chicago World's Fair recalls "My earnings began to hit \$20 to \$22 per week. This was real money." To attract customers, "we would say to the people, 'make a souvenir from your penny for five cents, just a nickel, folks, a souvenir of the Chicago World's Fair on your penny!'"



In the 1950s, after assurances from the US Treasury that elongating US coins is indeed quite legal, many more individuals created their own dies and rolling machines, establishing themselves over the next 30 or so years as particularly devoted elongated fans and building astonishing catalogs of elongateds, not to mention a nationwide network of friends.

Then in the late 1980s, a further expansion of the hobby occurred when customer operated electric and manual rolling machines began appearing at amusement parks, museums, zoos, and other attractions, providing seemingly endless opportunities for Happy Collecting! All of which brings us to today when some rare elongateds command high prices, but most still remain one of the least expensive and most unique collectibles available. Beloved by young and old alike, found at thousands of locations worldwide, elongateds are truly a joy.



Founded in 1966, The Elongated Collectors (TEC) now has over 750 members in several countries.
